### **THE MINISTRY OF INDUSTRY AND TRADE AND WILO SE HAVE DISCUSSED THE TERMS AND CONDITIONS FOR CONCLUDING A SPECIAL INVESTMENT CONTRACT. BEITEN BURKHARDT SUPPORTS THE PROJECT**

Moscow, 7<sup>th</sup> December 2016 – Deputy Minister of Industry and Trade of the Russian Federation Vasily Osmakov conducted a working meeting with the management of OOO Wilo Rus – subsidiary of the German Wilo SE on the conclusion of the special investment contract.

The meeting was attended by Jens Dallendoerfer, Vice-President of Wilo Group and General Director of OOO Wilo Rus, Mikhail Ivanov, Director of the Department of Machine Tool Building and Investment Mechanical Engineering of the Ministry of Industry and Trade of Russia, Falk Tischendorf, Managing Partner of BEITEN BURKHARDT Moscow, which provides legal support for the project, and also Sergei Vologodsky, Deputy Director of the Industrial Development Fund, and other representatives of the Ministry and the German company.

The participants at the meeting discussed the strategy of Wilo Group regarding the further localization of production in Russia, the procedure for implementing the requirements imposed on industrial products manufactured in the Russian Federation (Resolution No. 719 of the RF Government), and also the legal aspects of the special investment contract to be concluded.

Representatives of OOO Wilo Rus talked in detail about the activities of the company, a manufacturer and supplier of pumps for swimming pools and aqua parks, heating, water supply, water disposal, ventilation and fire-extinguishing systems. The aforementioned energy-efficient equipment is used at industrial enterprises and public utilities, and during the construction of buildings and other structures.
